Mae plismona cymunedau yng Ngogledd Cymru yn fater hanfodol i bawb. Tan 7 Ionawr, mae Andy Dunbobbin sef Comisiynydd Heddlu a Throedd Gogledd Cymru yn gofyn i bobl y rhanbarth ddweud faint o arian maen nhw'n barod i dalu am y gwaith mae'r heddlu yn ei wneud er mwyn cadw ein cymdogaethau'n saff.

Daw dros hanner yr arian ar gyfer cyllid yr heddlu yng Ngogledd Cymru o Lywodraeth y DU a daw'r gweddill oddi wrth Dreth y Cyngor. Mae'r swm mae pobl yn ei dalu yn eu treth gyngor yn dibynnu ar y praecept a osodir gan y Comisiwnwyr Heddlu a Throedd.

Last few days for the people of North Wales to say how much they will pay for policing

The policing of communities in North Wales is a crucial matter for everyone and until 7 January North Wales Police and Crime Commissioner Andy Dunbobbin is asking the people of the region to say how much money they are prepared to pay for the work the police do to keep our neighbourhoods safe.

Around half the money for the police budget in North Wales comes from the UK Government and the rest comes from Council Tax. The amount people pay in their Council Tax depends on the precept levied by Police and Crime Commissioners.

People will be able to give their view in the form of an online or paper questionnaire. There are questions on the options for the amount spent on policing, as well as what priorities people want to see North Wales Police concentrate on. Role will help road victims & families of people killed and seriously injured on roads

The families of people killed or seriously injured on the roads of North Wales, as well as people who have been seriously injured themselves, will be given high-quality support from an Independent Road Victim Advocate (IRVA), as part of a new service funded by the office of the Police and Crime Commissioner for North Wales.

John Hughes-Jones from North Wales, who takes up the role of IRVA, will be employed by Brake, the road safety charity. His role is funded by the PCC's office, which provides additional funding for a telephone service run by Brake that is offered to all road victims in England and Wales. [Read more here.](#)
