



On 1 February, Andy Dunbobbin visited RASASC in Bangor. The PCC got to learn more about how the funding received from his office has supported its work to help victims of sexual abuse.

The same day, Andy Dunbobbin also visited Maestryfan Community Group in Bangor. The group received funding from the PCC's Christmas Community Fund and plan to use the money to maintain and improve the outdoor public space.

On 2 February, the PCC visited the Hummingbird Project at their Hub in Water Street, Abergele to meet members of the team and learn more about their work and the funding given by the office has benefited them.

Finally on 6 February the PCC visited Shelby's Place in Buckley shopping centre to speak to members of the team about the aims of the organisation and the valuable outreach work it does as a hub of the community in Buckley.

All organisations received a certificate to recognise their work in the community.
