


<p>Cyflwynwyd adroddiad i'r Panel Heddlu a Throsedd ar 30 Ionawr 2020 yn argymhell y dylid codi'r praesept i £84,990,106 sef cynnydd o 4.89% yn y praesept, cyfwerth â chynnydd o 4.50% mewn Treth Cyngor.</p> <p>Roedd yr adroddiad hefyd yn cynnwys cynigion ar gyfer y blynnyddoedd 2020/21 tan 2024/25 a chyflwynwyd y cynllun ariannol tymor canolig er mwyn cefnogi'r adroddiad.</p> <p>Cafodd y cynnydd arfaethedig i'r praesept ei gadarnhau gan y Panel Heddlu a Throsedd.</p> <p>Derbynwyd setliad terfynol y grant ar 22 Ionawr 2020.</p>	<p>A report was taken to Police and Crime Panel on 30 January 2020 proposing that the precept be increased to £84,990,106, an increase of 4.89% in precept, equivalent to 4.50% increase in council tax.</p> <p>The report also included outline proposals for the years 2020/21 to 2024/25, and the medium term financial plan was presented to support the report.</p> <p>The proposed increase in precept was ratified by the Police and Crime Panel.</p> <p>The final grant settlement was received on 22 January 2020.</p>
