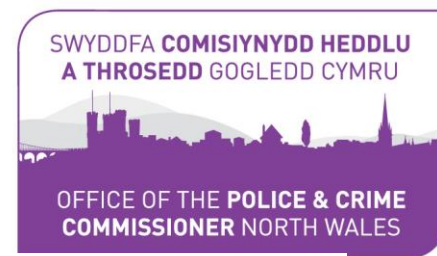



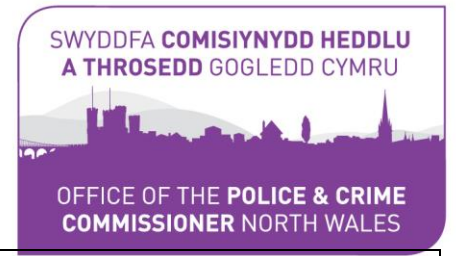

Crynodeb Gweithredol:	Executive Summary:
Yn dilyn cynnig yn y Bwrdd VAWDASV Gogledd Cymru penderfynwyd y dylai SCHTh fod y corff atebol (Bancwr Rhanbarthol) ar gyfer darparu gwasanaethau IDVA ledled yr ardal. Mae'r nawdd ar y cyd ar gyfer 2020/21 yn cynnwys y nawdd presennol gan SCHTh a grant VAWDASV (a dalwyd yn flaenorol i LA). Mae am gael ei gyfuno i un potyn i warchod y rhaglenni IDVA, ISVA, CSA a throseddwy'r presennol yn y chwe awdurdod lleol.	Following a proposal at the North Wales VAWDASV Board it was decided that the OPCC should be the accountable body (Regional Banker) for the provision of IDVA services across the area. The joint funding for 2020/21 includes the current funding by the OPCC and the VAWDASV grant (previously paid directly to the LA's) to be amalgamated into one pot to protect the current IDVA, ISVA, CSA and perpetrators programmes in all six local authorities.
