

This service is used regularly by North Wales Police who provide positive feedback and place great value on the services offered by Brake.</p> <p>Road crash bereavement packs are produced and distributed to Family Liaison Officers to support victims of road crashes. Support, awareness training and guidance to Family Liaison Officers is also offered by Brake.</p>
