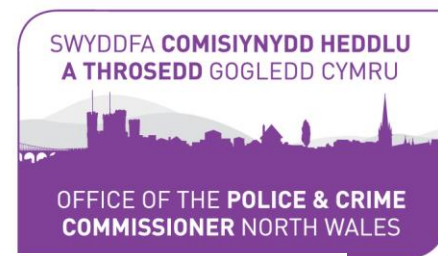

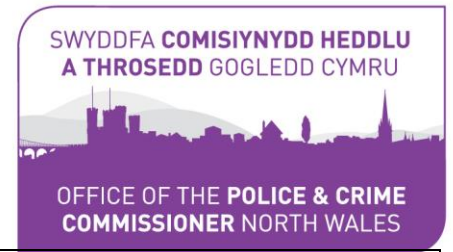

<p>Cytunodd Heddlu Gogledd Cymru a Gwasanaeth Tân ac Achub Gogledd Cymru (NWFRS) i gydweithio ar sefydlu Systemau Rheoli Cyfathrebiadau Integredig (ICCS) a thalodd NWFRS £244,444.65 i'r Comisiynydd Heddlu a Throsedd ar gyfer y pwrpas hwn.</p> <p>Penderfynodd y Gwasanaeth Tân ac Achub wneud eu trefniadau eu hunain ar gyfer sefydlu'r system a gofyn am ddychwelyd y blaendal.</p> <p>Ar ôl tynnu'r gwariant a wnaed gan Heddlu Gogledd Cymru am gostau yn perthyn yn uniongyrchol i Wasanaeth Tân ac Achub Gogledd Cymru, mae'r Comisiynydd Heddlu a Throsedd yn mynd i ad-dalu £201,219.63.</p>	<p>North Wales Police and North Wales Fire and Rescue Service (NWFRS) had an agreement to collaborate on the implementation of the Integrated Communications Control System (ICCS), and NWFRS paid £244,444.65 to the Police and Crime Commissioner for this purpose.</p> <p>North Wales Fire and Rescue Service then decided to make its own arrangements for the implementation of a system, and requested the return of the deposit.</p> <p>After deducting expenditure incurred by North Wales Police for costs directly attributable to North Wales Fire and Rescue Service, the Police and Crime Commissioner is to refund £201,219.63.</p>
