The funding will be allocated to fund additional staff hours, additional PEE equipment and room voids due to Covid-19 breakouts within refuges.</p> <p>This decision notices confirms the Commissioner's intentions for the distribution of the additional MOJ Funding.</p> <p>Allocation of funding is attached to this decision notice.</p>

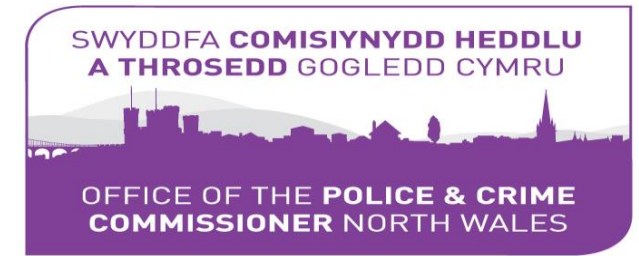

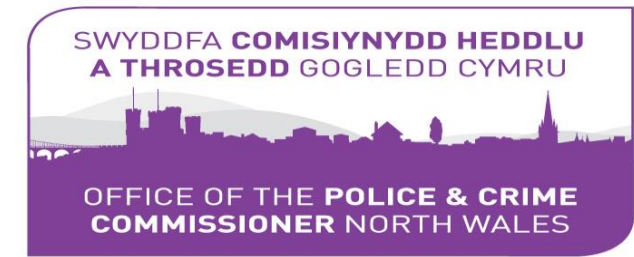
