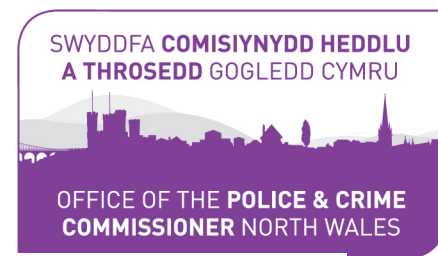

<p>Mae defnydd annigonol o Orsaf Heddlu Saltney ar hyn o bryd, ac fe nododd y strategaeth stadau hi fel bod ar gael i'w gwerthu o bosib. Amcangyfrifir y bydd yn cael ei gwerthu am £180,000.</p> <p>Ers i'r strategaeth stadau gael ei chwblhau, mae Gorsaf Heddlu Saltney wedi'i nodi fel bod yn llety addas ar gyfer tîm o swyddogion. Penderfynwyd cadw'r adeilad hwn am gyfnod cychwynol o 5 mlynedd iddynt ei ddefnyddio.</p>	<p>Saltney Police Station is currently underused, and the estates strategy identified it as being potentially available to sell. The estimated current sale value is £180,000.</p> <p>Since the estates strategy was finalised, Saltney Police Station has been identified as being suitable accommodation for a team of officers. It has been decided to retain this building for an initial period of 5 years for their use.</p>
