<p>Yn dilyn proses fynegi diddordeb lwyddiannus mae'r Weinyddiaeth Gyfiawnder wedi dyrannu £1,312,106 yn ychwanegol am 2 flynedd er mwyn cefnogi swyddi ISVA/IDVA ar draws gogledd Cymru.</p> <p>Bydd yr arian yn cefnogi cyfanswm o 4.8 swydd ISVA newydd ac 11.6 swydd IDVA. Yn ogystal, bydd gwasanaethau'n gallu defnyddio unrhyw danwariant a gafwyd yn 2021/22 ar gyfer costau cysylltiedig rhedeg gwasanaeth ISVA/IDVA gan gynnwys; gweithgareddau datblygu gwasanaethau, costau recriwtio, goruchwyliaeth glinigol a chostau gweinyddol.</p> <p>Bydd y Weinyddiaeth Gyfiawnder hefyd yn cael ei hymestyn ar gyfer ISVA llawn amser gyda'r Ganolfan Atgyfeirio Ymosodiadau Rhywiol tan 22/23.</p> <p>Mae'r hysbysiadau penderfynu hwn yn cadarnhau bwriadau'r Comisiynydd ar gyfer dosbarthu cyllid c Cam-drin Domestig / Trais Rhywiol y Weinyddiaeth Gyfiawnder.</p> <p>Mae dyrannu cyllid ynghlwm wrth yr hysbysiad penderfynu hwn.</p>	<p>Following a successful expression of interest process the Ministry of Justice have allocated an additional £1,312,106 for 2 years in order to support ISVA/IDVA posts across north Wales.</p> <p>The funding will support a total of 4.8 new ISVA posts and 11.6 IDVA posts. In addition services will be able to utilise any underspend incurred in 2021/22 for associated costs of running an ISVA/IDVA service including; service development activities, recruitment costs, clinical supervision and administrative costs.</p> <p>The MOJ will also be extended existing Rape Support funding for a full time ISVA with in the Sexual Assault Referral Centre until 22/23.</p> <p>This decision notices confirms the Commissioner's intentions for the distribution of the MOJ Domestic Abuse / Sexual Violence uplift funding.</p> <p>Allocation of funding is attached to this decision notice.</p>

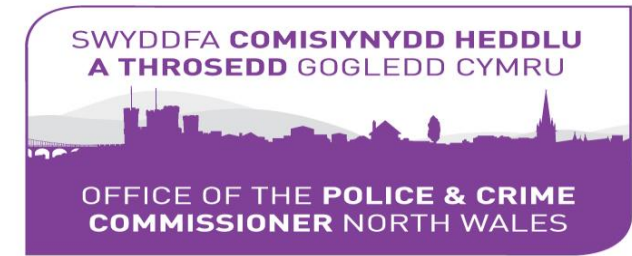

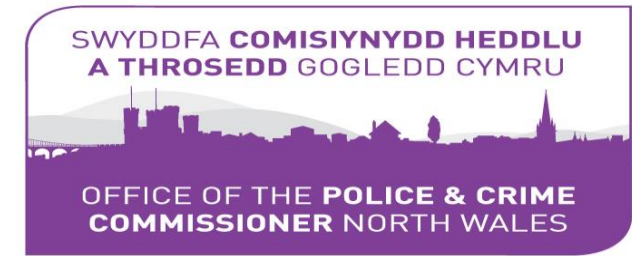
