National ANPR data Centre Temporary Solution

During September 2020 police forces were formally notified that the delivery of the National ANPR Service (NAS) R1.0, had been delayed beyond 2020 and is now planned for April 2021. It is highly likely that some of the capabilities outlined at the commencement of the NAS project will not be delivered as planned. The consequence of these delays has meant that a request has been made for forces to continue to feed their data to the NADC. The NADC is the national ANPR data centre for the collection of Automatic Number Plate Recognition (ANPR) data from Force ANPR back office facilities. NAS was intended to replace NADC but the requirement is now to feed both systems concurrently.

Waiver to cover this ongoing requirement whilst the national service is progressed

Neighbourhood Alert

Neighbourhood Alert System, The market assessment identified several options but only the Neighbourhood Alert system met our specification and functional statement of requirements and provides a cost-effective solution, and there is insufficient time to tender in order to secure the 5 year grant funding.

Drones Software

The system will manage pilot, training, compliance, deployment and maintenance management system. Based on the research into the market place, other forces and suppliers, there are only 2 suppliers of this software, however one system does not have the ability to allow pilots to utilise at scene or communicate directly with the CAA, therefore this leaves only one other supplier who offers the full services that NWP require.

RF survey equipment

Survey equipment this equipment allows the cybercrime team to provide the force with the capability to conduct radio frequency propagation surveys and download internet routers. The rationale behind the purchase requirement of this particular equipment is due to the end of life of our current RFPS (radio frequency propagation surveys) kit. This is specialist Kit with only one UK supplier at this time .
