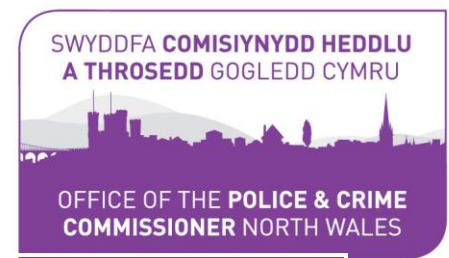

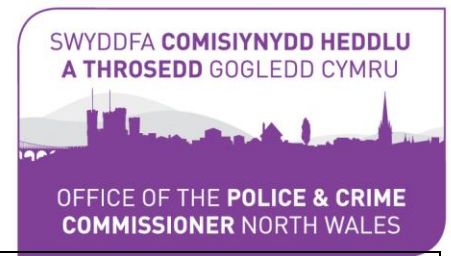

Darperir cyllid ychwanegol o Grant Cefnogi Dioddefwyr gan y Weinyddiaeth Gyfiawnder i gefnogi Eiriolwr Annibynnol ar Drais Rhywiol (ISVA) ychwanegol yng Nghanolfan Atgyfeirio Ymosodiadau Rhywiol (SARC) am 2 flynedd. Mae'r SARC yn darparu cefnogaeth i blant ac oedolion sydd wedi dioddef trais rhywiol ynghyd â'u teuluoedd a'u hanwyliaid. Mae gwasanaeth ISVA wedi sefydlu llwybrau ar gyfer atgyfeirio mewnol gyda nifer o asiantaethau ac yn gweithio'n gyson i ddarparu gwasanaethau effeithiol i unigolion a'u teuluoedd.	Additional funding has been secured from the Victims Support Grant provided by the Ministry of Justice to support an additional full time Independent Sexual Violence Advisor (ISVA) based within the Sexual Assault Referral Centre for 2 years. The SARC provides support to adult and child victims of sexual violence, and their families and significant others. The ISVA service has established pathways for inter-referral with many agencies and works consistently to provide effective services to individuals and their families.

Cyfreithiol: Mae Deddf Diwygio'r Heddlu a Chyfrifoldeb Cymdeithasol 2011 yn galluogi'r Comisiynydd i roi grantiau i bartneriaid, sefydliadau cyhoeddus neu grwpiau gwirfoddol a all gynorthwyo'r blaenoriaethau diogelwch cymunedol a nodir yn y Cynllun Heddlu a Throsedd. Cynllun Heddlu a Throsedd: Bydd y gwaith hwn yn helpu'r Comisiynydd i ateb ei ddyletswydd statudol o gyflwyno gwasanaeth effeithiol ac effeithlon yng Ngogledd Cymru. Bydd y gwaith hwn yn cael ei fonitro drwy adroddiadau ar y prif bwyntiau, cyflwyno data ac ymweliadau monitro gan Swyddfa'r Comisiynydd Heddlu a Throsedd: Bydd diweddariadau pellach yn ymwneud â'r gwasanaeth yn cael eu trafod ym Mwrdd VAWDASV.	Financial – An additional £76,824.00 has been made available from the Victims Support Services grant provided by the Ministry to support the ISVA provision from 2020-2022. Legal: The Police Reform and Social Responsibility Act 2011 enables the Commissioner to award grants to partners, public organisations or voluntary groups that can support the community safety priorities identified in the Police and Crime Plan. Police and Crime Plan: This area of work will help the Commissioner meet his main statutory duty of delivering an effective and efficient policing service in North Wales. This work will be monitored through highlight reports, data submissions and monitoring visits conducted by the Office of the Police and Crime Commissioner. Further updates regarding the service will be tabled at the VAWDASV Board.
