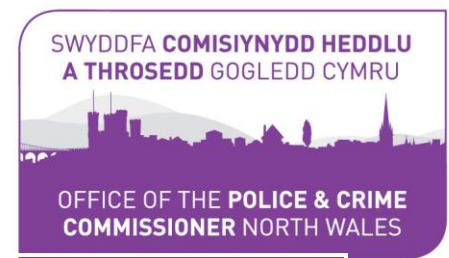



<p>Mae'r Swyddfa Comisiynydd Heddlu a Throsedd wedi rhoi cyfraniad bach i'r Rhaglen Troseddwyd Choose 2 Change.</p> <p>Mae'r Rhaglen yn cyflwyno ymyriad achrededig RESPECT er mwyn ymdrin â cham-drin domestig. Mae'r prosiect yn cyflwyno rhaglen gwaith grŵp ar gyfer troseddwyd er mwyn rhoi cyfle i ddynion sydd wedi bod yn cam-drin o fewn perthynas glos i newid a gwasanaeth cymorth i gyn bartneriaid dynion sy'n ymgysylltu gyda'r gwasanaeth.</p> <p>Nod y gwasanaeth yw gwella diogelwch merched a phlant drwy leihau'r lefel/au cam-drin domestig maent yn dioddef, lleihau'r nifer o achosion o gam-drin domestig a dioddefwyr mynych/newydd.</p> <p>Mae dwy elfen y gwasanaeth yn gweithio gyda'i gilydd i fagu dealltwriaeth lawn o risg ym mhob achos a gosod cynllun rheoli risgiau cadarn. Mae'r gwasanaeth yn chwarae rhan weithredol ar yr ymateb amlasiantaeth i gam-drin domestig gan roi gwybodaeth am risgiau ac ymgysylltu â throseddwyd drwy MARAC, ADAPT, VAWDASV a meysydd Diogelu.</p>	<p>The Office of the Police and Crime Commissioner has provided a small contribution to the Choose 2 Change Perpetrator Programme.</p> <p>The Programme delivers a RESPECT accredited intervention to address domestic abuse. The project delivers both a group work perpetrator programme to offer men who have been abusive in intimate relationship/s an opportunity to change and a support service for the ex/partners of the men engaging with the service.</p> <p>The aims of the service are to increase the safety of women and children by reducing the level/s of domestic abuse they are experiencing, reduce the number of domestic abuse incidents and repeat/new victims.</p> <p>Both elements of the service work together to gain a full understanding of risk in each case and put in place a robust risk management plan. The service plays an active part on the multi-agency response to domestic abuse providing information about perpetrator risk and engagement at MARAC, ADAPT, VAWDASV and Safeguarding arenas.</p>
