The Commissioner is required before the beginning of the financial year to:</p> <ul style="list-style-type: none"> • Formally agree the Capital Programme as part of the Capital Strategy; • Provide the strategy framework for Treasury Management; • Agree the Treasury management and Prudential Indicators; • Agree the method adopted for the repayment of debt (Minimum Revenue Provision). • <p>The draft Capital Strategy and draft Treasury Management Strategy were discussed by the Joint Audit Committee on 1 April 2022.</p>
