Welcome to my first Annual Report as Chair of Trustees.

I took over as Chair just in time to see the country go into lockdown and the challenges that the pandemic has brought to our communities. Plainly this also brought about many challenges to PACT and the board of trustees, not least of which was the introduction of virtual meetings and the prevailing technology.

Whilst a number of our usual activities had to be curtailed or cancelled in 2020 – including our Justice in a Day schools programme and our High Sheriffs Awards evenings– I am delighted to report that PACT has continued to support local community groups and Neighbourhood Policing Teams throughout these difficult times, and indeed our Project Manager has also been involved in supporting communities as a member of the Local Resilience Forum Volunteer Group working with County Voluntary Councils and a variety of community groups across North Wales.

2020/21 also saw PACT deliver the eighth round of funding of 'Your Community Your Choice'. Launched in 2013, this continues to be a hugely popular fund which this year saw £60,000 being made available to local community initiatives. Once again, this was funded equally between the Commissioner's Fund and monies recovered from criminals under the Proceeds of Crime Act. Following on from the previous year's theme of 'Building Resilient Communities' we developed this to 'Strengthening Resilient Communities' with a focus on support and recovery during and after lockdown. 'Your Community Your Choice' again attracted a high quality of applications. 48 applications were received of which 43 went forward for the public vote.

This year saw a record number of public votes being cast – over 32,000 - resulting in 21 community organisations receiving their cheques in February 2021.

Under my guidance we continue to manage the Police Property Act Fund on behalf of the OPCC with the PACT Small Grant Fund and Main Grant continuing be the mainstay of our funding together with the High Sheriffs' Crimebeat Youth Fund. Despite the pandemic we have been able to support over 80 projects in 2020/21.

You can find details of these grants in the appendix to this report.

During 2020/21 I commissioned Wrexham Glyndŵr University to undertake research with almost 300 PACT grant recipients to assess the value and impact of our grants. The findings of this independent research are overwhelmingly positive, with 94% of projects reporting improved community relations following PACT support; 98% of projects positively impacting on policing priorities and 92% of respondents believing the wider community had benefitted from the intervention they had delivered through the charity.

Additionally 75% of respondents said their projects would either not have happened, or would have happened on a smaller scale, without PACT.

The report clearly underlines the value that PACT funding can bring to our communities, either as a stand-alone funder or, as in many cases, as a valuable partnership funding arrangement.

As we move into a new financial year, and as our lives return to a new normal I and my fellow trustees will be using the findings of this research to further develop and build on the existing work of PACT increasing its impact and effectiveness across North Wales for the benefit of our communities.

Finally I would like to express my thanks to my fellow trustees, North Wales Police, Chief Constable Carl Foulkes and PCC Arfon Jones for their support during my first year as Chair.

Trustees Annual Report

The Trustees have pleasure in presenting their report and the financial statements of the charity for the year ended 31st March 2021.

Objectives

The Trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning future activities and setting the grant making policy for the year. In all activities the Trust seeks to raise the profile of Community Safety and, through the protection of people and property, significantly minimise the fear of crime thereby enhancing quality of life throughout the region. The activities include:

- Promoting crime prevention initiatives.
- Promoting Road Safety as an integral part of life to the people of North Wales through training, education, publicity, and special projects.
- Educating the people of North Wales in all matters relating to drug, alcohol and other substance abuse thereby helping to reduce drug-related crime.
- Developing educational programmes for the benefit of young people and others.

Constitution

The North Wales Police and Community Trust was launched on 14th October 1998. The trust is a registered charity under the Charities Act 1993. The Charity registration number is 1071628.

Governing Documents

The Trust is governed by the Declaration of Trust (Trust Deed), which was formally made on 9th September 1998.

Organisation of the Charity

The Trust is run by the Board of Trustees. In accordance with the Declaration of Trust, the Board of Trustees, when complete, should consist of up to thirteen Trustees representing North Wales Police, the voluntary sector, the business sector, and the High Sheriffs of Clwyd and Gwynedd.

Premises

The administration office of the Trust is carried from offices at:

Restrictions of the Trust's Activities

The activities of the Trust are restricted to the objectives as outlined in the Declaration of Trust as approved by the Charities Commissioners. The area that can benefit from the Trust's activities is restricted to North Wales.

Policy on Reserves

The Trustees are aware of the Charity Commissioners requirement in regard to Reserves policy.

The Trustees regularly review the level of reserves held by the Trust, and are satisfied that these are kept at an acceptable level to ensure that the Trust continues to operate effectively.

Independent Examination

In accordance with PACTs original Declaration of Trust the trustees confirm that, as the Trusts annual turnover is less than £500,000 an Independent Examination is required. Should the Trust's turnover exceed this level then a full Audit will be required.

In all its activities PACT strives to support the objectives of the Police and Crime Plan, reducing crime and anti-social behaviour and helping to make North Wales the safest place in which to live and work and to visit.

Police Property Act Fund

PACT Trustees continue to manage the Police Property Act Fund on behalf of the Police and Crime Commissioner.

The Police Property Act Fund is made up of monies received by the police from the sale of found property and from property which is confiscated by order of the courts and then sold. The main aim of the fund is to support local projects undertaken by voluntary/charitable organisations that solely benefit the communities of North Wales.

Our Small Grant Fund and Main Grant Fund continue to be a mainstay of our funding. Despite the pandemic PACT was able to support over 80 projects this year which you can see listed in the appendix.

This year, through our Main Grant Fund, PACT has been able to support Bayside Radio in Colwyn Bay, the volunteers of 4x4 Response North Wales who have worked tirelessly during the pandemic, the Abbey Up-cycling Project for adults with learning difficulties in Flintshire, Holyhead Sailing Club working with young people on Anglesey, Colwyn Bay Disability Rugby Club and many others Once again, our Small Grant Fund continues to be extremely popular with our Neighbourhood Policing Teams. The fund, which allows officers to apply for grants of up to £250, is now in its 21st year.

The value of this funding has been highlighted by the ImPACT Report conducted by researchers at Wrexham Glyndwr University.

The results of this expansive research has shown that for many who are involved in our projects, this is their first interaction with the police, and by making this first contact with police a positive experience it can have profound consequences on their future life choices as well as their relationship with the justice system. Indeed, 75% of those interviewed said their projects would either not have happened or happened on a smaller scale without PACT.

The results of the survey have shown PACT to be a valuable tool for both the police and the communities of North Wales and PACT funding is making a real difference. It is improving the lives of individuals, helping organisations to sustain and grow essential services, helping communities become safer and stronger, and helping North Wales Police to deliver its service more effectively. The survey has shown that 94% of projects report improved community relations following PACT support, 98% of projects positively impacting on policing priorities and 92% of respondents believe the wider community had benefitted from the intervention they had delivered through the charity. Justice in a Day



Our 2020 programme was well under progress when the pandemic struck and forced the early conclusion of our schedule just as we approached the halfway mark.

Once again the theme was County Lines and young people becoming victims of County Lines and the gangs which use them as local distributors in our communities.

During the two weeks we were able to engage with schools we had seen over 330 pupils attend from 19 secondary schools across North Wales, and once again we were supported by Police Community Support Officers, HM Courts and volunteer magistrates.



The pandemic meant that our planned 2021 programme was cancelled. We are extremely grateful to our co-funders', the Moondance Foundation and the OPCC, for their continued support and understanding during the past year.

Along with our partners at Theatr Clwyd we aim to return in 2022.

Your Community Your Choice

Supporting projects that reduce crime and anti-social behaviour.

'Criminals pain – Communities gain'

This year's 'Your Community Your Choice' saw over 32,000 votes being cast in support of projects across North Wales by members of the public.

Three organisations in each county were successful and were presented with their cheques on 25th February 2021 at a virtual ceremony hosted by Police and Crime Commissioner, Arfon Jones, Assistant Chief Constable Sasha Hatchett and Ashley Rogers, Chair of the North Wales Police and Community Trust (PACT)

Ashley commented: "Your Community Your Choice is a really valuable way of supporting communities and putting the choice of which projects are supported in the hands of the public. It's a very democratic process which is why I think it's been such a long running and successful scheme.

"Your Community Your Choice is a fantastic project to be involved with and you can directly see the benefits from the funding in strengthening our resilient communities. I want to say a huge 'Thank You' to all of this year's applicants for the work that they are doing to support the Police and Crime Plan, their local Neighbourhood Policing Teams and most importantly – their communities."

Assistant Chief Constable Sacha Hatchett said: "This money includes cash from assets seized from criminals under the Proceeds of Crime Act. This is a particularly vital message as, through the professionalism of North Wales Police Officers and with the support of the Courts, we are able to hit the criminals where it hurts – in their pockets."

Crimebeat Activity 2020/21

crimebeat

Our two High Sheriffs, David Wynne-Finch and Eryl Williams, took up their office just as lockdown began. Both had to make their Declarations at home instead of their planned ceremonial events. 2020 also meant that Crimebeat grants were vastly reduced and the High Sheriffs were only able to make a small handful of public engagements with much of their work being undertaken virtually.

This included the inaugural High Sheriff Police Cadet Challenge. Launched in October 2020 by David Wynne-Finch, High Sheriff of Clwyd and Eryl Williams, High Sheriff of Gwynedd, senior Cadets were set an on-line challenge to develop a plan that would help reduce crime and/or antisocial behaviour in their communities.



Topics chosen by the Cadets included litter and the environment, home security to prevent burglaries, and young people's issues.

Four proposals were short-listed for the judging panel to assess which saw Cadets make their virtual presentations to the High Sheriff's.


Volunteer Police Cadets Jacob Riddle together with Sunshine Bowers, Morgan Davies, Samuel Griffiths and Joshua Taylor each gave 10 minute

presentations to the judging panel consisting of the High Sheriffs of Clwyd and Gwynedd, Dr. Peter Harlech Jones and High Sheriff Cadet Eve Perring in her last official duty before leaving to study Criminology at Lancaster University.

An extremely high standard of ideas saw VPC Joshua Taylor win the Challenge and receive a £50.00 Amazon Gift Voucher in recognition of his outstanding work.

Virtual award ceremonies saw High Sheriff of Gwynedd, Eryl Williams, present certificates to members of the Royal College of Nursing in recognition of their outstanding work during the pandemic; and in Clwyd, David Wynne-Finch presented certificates to volunteers in both Conwy and Wrexham following invitations from CVSC and AVOW.





In January 2021 the High Sheriffs helped to launch the North Wales Primary Schools Internet Safety Competition, setting them a challenge to create an internet safety poster with a chance of winning some fantastic prizes for their schools. Sponsored by Crimebeat in Clwyd and Gwynedd, the competition was launched in response to the sharp increase in the time youngsters are spending online since the beginning of the Coronavirus pandemic back in March 2020. The competition is still on-going as we write this report.

One of the highlights of the year was the national recognition for one our projects – 'Sharing Stories' – which won the National Crimebeat Youth Led project of the Year. We were able to hold a virtual award ceremony when both High Sheriffs were joined by representatives from National Crimebeat. Welcoming everyone to the virtual event the High Sheriff of Clwyd, David Wynne-Finch said: "This is a moving and deeply personal project which has been devised and developed by young people in North Wales who have been victims of sexual violence and is aimed at helping and supporting other young people who are encountering similar circumstances.

"With the support of Hannah Mart, Stephanie Williams and the team at the Amethyst SARC based in Colwyn Bay these young people have produced something quite magnificent and I know that all of us will be moved by their work. The Award celebrated the selfless and considerable efforts that have been carried out by our wonderful young people without any thought of recognition or reward."



Eryl Williams, High Sheriff of Gwynedd added: "Through our Crimebeat charity High Sheriffs play an active role in promoting the work of young people within their communities. High Sheriffs give our own personal awards to individuals, often unsung heroes within our communities, who have made an outstanding contribution in some way. And so it is such an honour for Crimebeat in North Wales to have a project that we have supported to be recognised at a national level."

The role of the High Sheriffs is to lend active support to their county, including the emergency services and law-enforcement agencies. They ensure the welfare of visiting High Court Judges, support royal visits and take an active part in supporting and promoting voluntary organisations.

Crimebeat is the official charity of the High Sheriffs, which aims to support young people who want to make a difference in their communities. Crimebeat funding gives young people a unique opportunity to use their energy and imagination to develop specific initiatives to reduce crime and anti-social behaviour.

B.A.N.G. – Be A Nice Guy 2020



Together with North Wales Police and the Arson Reduction Team PACT has once again joined forces to ask people to 'Be a Nice Guy' with grants available through Operation BANG to support local initiatives that address deliberate fire-setting and anti-social behaviour over the Hallowe'en and Bonfire period.

By working with key partners such as the North Wales Fire and Rescue Service, Community Safety Partnerships and local authorities, we are able to promote key messages through the 'Be a Nice Guy' initiative.

It has been identified that this approach, along with targeted diversionary activities which engage young people in fun and entertaining events, can be very effective in ensuring that everyone can enjoy themselves safely.

Notes to the Accounts

1. Accounting Policies

The principal accounting policies are summarised below. The accounting polices have been applied consistently throughout the year and in the preceding year.

a) Basis of Accounting

The accounts are drawn up on an accruals basis and in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities issued in March 2005.

b) Fund Accounting

- Unrestricted Funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity.
- Restricted Funds are subject to restrictions on their expenditure imposed by the donor.

c) Incoming Resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

• Voluntary income is received by way of grants, donations and gifts and is included in full in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.

- Donated services and facilities are included at the value to the charity where this can be quantified.
- Investment income is included when receivable.
- Incoming resources from grants, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance.

d) Resources Expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates:

- Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.
- Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the independent examination fees and costs linked to the strategic management of the charity.

• All costs are allocated between the expenditure categories of the SoFA on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly, others are apportioned on an appropriate basis e.g. floor area.

2. Employees Remuneration

No employees were paid by the trust during the period. The services of a Project Manager/ Crimebeat Co-ordinator were donated by North Wales Police. This cost is included in the statement of financial activities.

3. Trustees Remuneration and Expenses

None of the Trustees, nor any connected persons, received any remuneration during the period.

No reimbursement of Trustees expenses, or any other connected persons, was made during the period.
