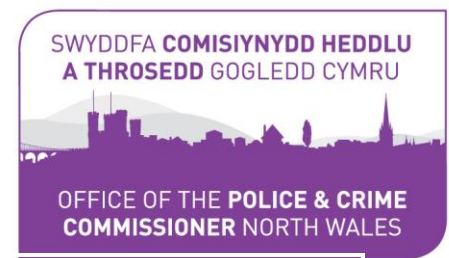


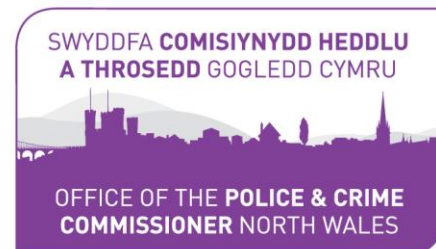

By understanding the underlying causes of their offending behaviours, pathfinder will steer women away from crime by providing opportunities to reform and rehabilitate.</p> <p>The Women’s Pathfinder project will provide interventions to women who have been diverted via the Custody based Checkpoint service as an alternative to being charged for low level offence. The service also accepts women who are at risk of entering the Criminal Justice system and women can be referred through agencies or self-refer in some circumstances.</p> <p>This contract is ends on the 30th of September 2022.</p>
