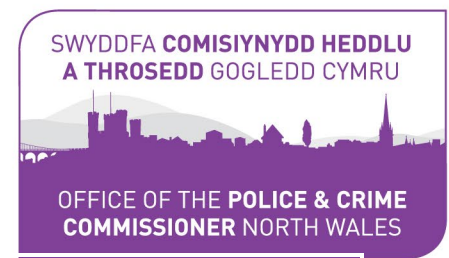


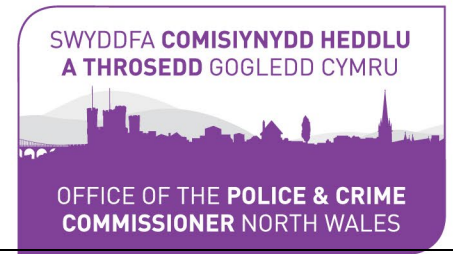

<p>Ar 6 Ebrill 2021, cymeradwyodd y Comisiynydd Heddlu a Throsedd:</p> <ul style="list-style-type: none"> <li>• y cynnig i ddatblygu, mabwysiadu Strategaeth Genedlaethol sy'n cael ei chyd-berchnogi ac sy'n cynnwys gweledigaeth a glasbrint a rennir i'w cyflawni o fewn yr amserlenni a amlinellir yn y Ddeddf VAWDASV.</li> <li>• ffurfioli partneriaeth rhwng Llywodraeth Cymru, GCPHEM, Heddluoedd Cymru a Chomisiynwyr Heddlu a Throsedd sy'n creu tîm integredig i oruchwylio a rheoli prosiect a rennir a chytuno mewn egwyddor i ddyrannu adnoddau er mwyn gweithredu'r ymrwymiad a amlinellir yng Nghyfnod 1.</li> <li>• yr amserlen lefel uchel arfaethedig a geir yn y papur fel arweiniad i gyflawni.</li> <li>• cyfrannu £26,850.48 tuag at y Strategaeth.</li> </ul> <p>Ers i'r penderfyniadau uchod gael eu gwneud, mae'r tîm Glasbrint dros dro wedi ailymweld â'r gyllideb a'r gofynion adnoddau ar gyfer gweithredu a chyflawni'r Strategaeth VAWDASV newydd. Mae gofynion 22-23 wedi cael eu croesyfeirio o ran papurau adnoddau blaenorol er mwyn adlewyrchu dealltwriaeth presennol o anghenion adnoddau o ran blaenoriaethau cyflawni.</p> <p>Mae'r tîm Glasbrint felly'n gofyn am benderfyniad am gyllid pellach gan y CHTh (2022-23) fel cyfraniad partneriaeth ar gyfer y tîm cyflawni glasbrint creiddiol. Gofynnir am <b>£38,125</b> i bob CHTh yng Nghymru fel y dadansoddir isod.</p>	<p>On 6 April 2021 the Police and Crime Commissioner approved:</p> <ul style="list-style-type: none"> <li>• the proposal to develop, adopt a National Strategy that is jointly owned and contains a shared vision and blueprint for delivery within the timescales set out in the VAWDASV Act.</li> <li>• to formalise a partnership between Welsh Government, HMPPS, Welsh Police Forces, Police and Crime Commissioners that creates an integrated team to oversee and manage a shared project and agree in principle to allocate resources to implement commitment outlined in Phase 1.</li> <li>• the proposed high-level timeline included in the paper as a guide for delivery.</li> <li>• contribute £26,850.48 towards the Strategy</li> </ul> <p>Since the above decisions was made the interim Blueprint team has re-visited the budget and resource requirements for the implementation and delivery of the new VAWDASV Strategy, the requirements for 22-23 have been cross-referenced against previous resource papers to reflect current understanding of resource needs against delivery priorities.</p> <p>The Blueprint team are therefore requesting a decision for further PCC funding (2022-23) as a partnership contribution for the core blueprint delivery team. The financial ask for each PCC in Wales is <b>£38,125</b> as broken down below.</p>
