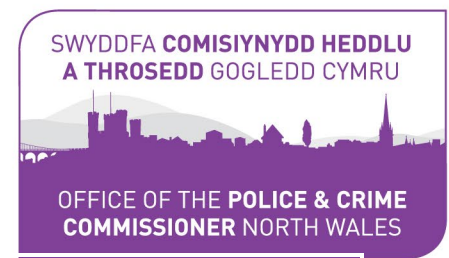

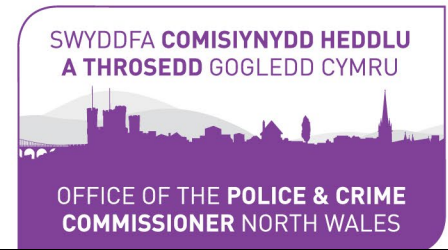

<p>Gofynnwyd am gyfraniadau tuag at gefnogaeth busnes a gweinyddu ar gyfer Bwrdd Partneriaeth Strategol Gogledd Cymru.</p> <p>Nodwyd ar draws y bartneriaeth Arweinyddiaeth Rhanbarthol bod angen cefnogaeth busnes a gweinyddu cyson ar gyfer strwythur arfaethedig newydd a chost cyfieithu i'r Gymraeg. Mae achosion busnes ar gyfer Swyddog Datblygu Busnes a Swyddog Gweinyddu wedi bod ar gael i bob partner. Rhagwelir y bydd y swyddogion yn eistedd naill ai o fewn y Bwrdd Cynllunio Ardal (APB) neu o fewn Cydweithredfa Gwella Gwasanaethau Gofal a Llesiant Gogledd Cymru (NWSWIC). Mae'r APB wedi nodi y buasant yn ystyried ariannu rhan o gost rôl y swyddog gweinyddu.</p> <p>Mae'r CHTh wedi cytuno i'r argymhelliad i ariannu'r swyddi at swm o £100k wedi ei rannu rhwng 12 asiantaethau partner,¹ gall hyn gynnwys costau ar gyfer dau swyddog (ynghyd ag ar gostau) a chostau cysylltiedig fel cyfieithu i'r Gymraeg.</p>	<p>Financial contributions towards business and administration support for the new North Wales Strategic Partnership Boards has been requested.</p> <p>It has been identified that across the Regional Leadership partnership there is a need for consistent business and administration support for the proposed new structure and the inherent Welsh translation costs. Business cases for a Business Development Officer and Administration Officer have been available to all partners. It is envisaged that the posts would sit either within the Area Planning Board (APB) or the North Wales Social Care and Wellbeing Improvement Collaborative (NWSWIC). The APB have indicated they would consider funding a proportion of the costs of the Administration officer role.</p> <p>The PCC has agreed to this recommendation to fund the posts for a sum of £100k shared between the 12 partner agencies², this would include costs for two officers (together with on costs) and associated costs such as Welsh translation.</p>
