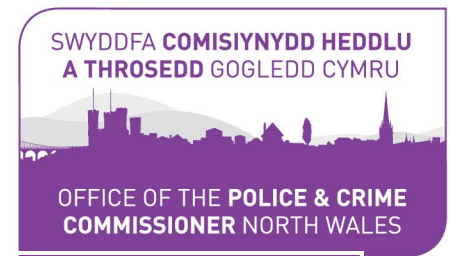

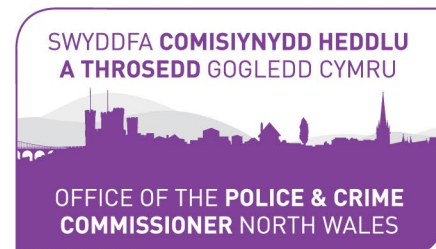

Cynigiwyd swydd Dirprwy Gomisiynydd Heddlu a Throsedd i ddeiliad y swydd weithio 30 awr yr wythnos. Mae'n amlwg bellach bod y rôl yn un llawn amser, ac felly penderfynwyd cynyddu'r oriau i 37 yr wythnos, o 1 Ionawr 2022 ymlaen.	The Deputy Police and Crime Commissioner post was offered to the postholder to work 30 hours per week. It is now apparent that the role is a full-time one, and therefore it has been decided to increase the hours to 37 per week, with effect from 1 January 2022.
