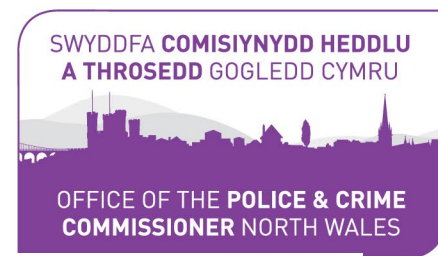

It was decided at the Policing in Wales meeting (8/9 June 2023) for Police and Crime Commissioners and Forces in Wales to jointly provide sponsorship of £15,000 for the conference which will take place in October 2023.
