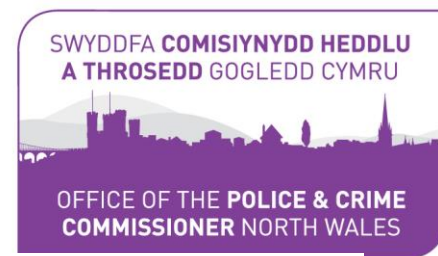


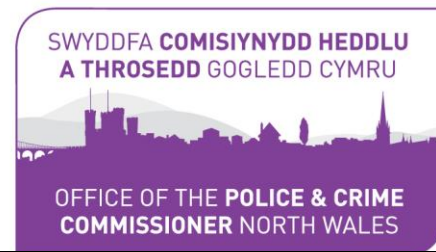

<p>Cais yw hwn i gael grant i recriwtio Gweithiwr Achos i Blant a Phobl Ifanc o fewn Canolfan Gymorth Dioddefwyr yn Llanelwy, Sir Ddinbych fel rhan o brosiect 12 mis.</p> <p>Penderfynwyd ar y rôl yn dilyn atgyfeiriadau cynyddol i'r ganolfan gan blant a phobl ifanc sydd wedi cael eu heffeithio gan droseddau. Ar hyn o bryd mae'r Ganolfan Cymorth Dioddefwyr yn rhoi cefnogaeth drwy eu teuluoedd ac yn dilyn adborth teimlwyd bod angen cefnogaeth uniongyrchol ar blant.</p> <p>Bydd y prosiect yn cyflogi Gweithiwr Achos Aml-drosedd Plant a Phobl Ifanc i gefnogi plant a phobl ifanc sydd wedi cael eu heffeithio gan drosedd i wneud iddynt deimlo'n fwy diogel, yn fwy gwybodus, gyda mwy o gysylltiadau gan fagu eu hyder a'u lles. Y rôl yw'r cyntaf o'u bath o fewn gwasanaethau dioddefwyr ar draws Cymru.</p> <p>Byddai'r rôl yn gweithio mewn partneriaeth ar y cyd gyda phlant eraill a sefydliadau pobl ifanc yn cynnwys RASASC, DASU a chanolfannau teuluoedd yr awdurdodau lleol.</p>	<p>This a request to provide grant funding to recruit a dedicated Children and Young People Caseworker within the Victim Help Centre in St Asaph, Denbighshire as part of 12-month pilot project.</p> <p>The role was identified following increased referrals to the centre specifically for Children and Young People affected by crime. Currently the Victim Help Centre provide support via their families and following feedback it was felt that children required direct support.</p> <p>The project will provide a full time Children and Young People Multi-Crime caseworker to support children and young people affected by crime to make them feel safer, more informed, better connected, and increase their confidence and wellbeing. The role is the first of its kind within victim services across Wales.</p> <p>The role would work in partnership alongside various other children and young people organisations including RASASC, DASU and local authority families' centres.</p>

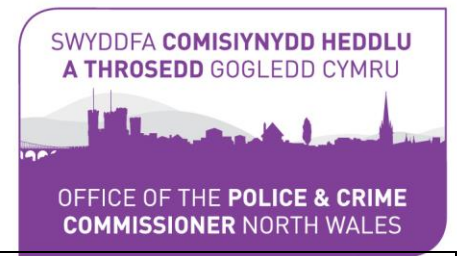
