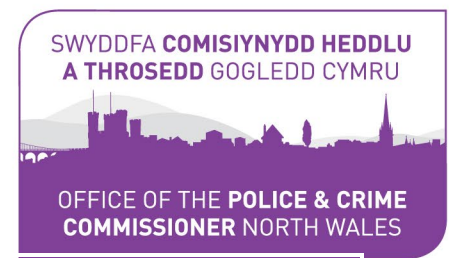


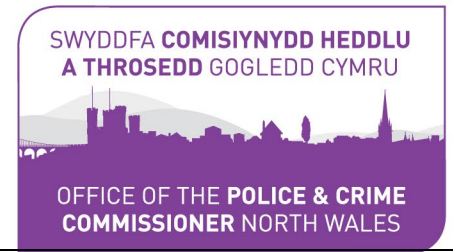

Crynodeb Gweithredol:	Executive Summary:
Mae Canolfan Driniaeth yr Heddlu yn darparu gwasanaethau meddygol i swyddogion yr heddlu, gan gynnwys cwnstabiliaid gwirfoddol. Mae cwnstabiliaid gwirfoddol yn ddi-dâl, ac ni chaniateir iddynt fod yn aelodau o Ffederasiwn yr Heddlu, sy'n darparu llawer o'r cyllid ar gyfer Canolfan Driniaeth yr Heddlu. Penderfynwyd y bydd y Comisiynydd Heddlu a Throsedd yn gwneud cyfraniad o £2,500 (cyfanswm o £5,000) yn 2022/23.	The Police Treatment Centre provides medical services to police officers, including special constables. Special constables are unpaid, and are not permitted to be members of the Police Federation, which provides much of the funding for the Police Treatment Centre. It has been decided that the Police and Crime Commissioner and Force will each make a contribution of £2,500 (£5,000 total) in 2022/23.

Mae gwasanaethau meddygol amserol a phriodol yn lleihau absenoldeb oherwydd salwch neu anaf.</p> <p>Cydraddoldeb – Mae'r penderfyniad hwn yn sicrhau bod pob swyddog, gan gynnwys cwnstabiliaid gwirfoddol, yn gallu cael mynediad i Ganolfan Driniaeth yr Heddlu yn seiliedig ar angen meddygol, ac nad yw'n dibynnu ar aelodaeth o undeb plismona.</p>	<p>Financial – The cost of £5,000 can be accommodated within the OPCC and force budgets in 2022/23.</p> <p>Police and Crime Plan – Ensuring officers, including special constables, receive timely and appropriate medical treatment minimises sickness abstraction and therefore allows the maximum policing resource to be available to deliver the Police and Crime Plan.</p> <p>Welsh language – none</p> <p>HR – The HR department currently prioritises health and wellbeing as it is of significant benefit to the force.</p> <p>Timely and appropriate medical services reduce absence due to sickness or injury.</p> <p>Equality – This decision ensures that all officers, including special constables, are able to access the Police Treatment Centre based on medical need, and does not depend on membership of a policing union.</p>
