




Er mwyn sicrhau gwytnwch wrth ymdrin â'r achosion hyn, mae'r CHTh yn dirprwyo'r swyddogaeth hon i'r Digrwy Gomisynydd Heddlu a Throedd a/neu y Prif Weithredwr/Swyddog Monitro.	<b>Executive Summary:</b>  The Police and Crime Commissioner (PCC) is the Appropriate Authority to consider complaints about the Chief Constable and is also the Relevant Review Body to consider complaints which have been dealt with by the Force's Professional Standards Department.  These are statutory duties that may be delegated to the Deputy Police and Crime Commissioner and/or the Chief Executive/Monitoring Officer to consider on behalf of the PCC.  To ensure resilience in dealing with these cases, the PCC is delegating this function to the Deputy Police and Crime Commissioner and/or Chief Executive/Monitoring Officer.
