



Crynodeb Gweithredol: Mae Heddlu Gogledd Cymru wedi gofyn am hepgoriad o ran caffael darpariaeth rheoli i'r Proiect FCIN. Mae'r gwasanaeth angenrheidiol yn estyniad o'r cyswllt presennol hyd nes y gellir cael y ddarpariaeth yn fewnol. Mae'r darparwyr presennol yn darparu gwasanaeth o ansawdd uchel. Dyma'r ail gais am hepgoriad, gwelwch hepgoriad 2022.20 sydd wedi cael ei gymeradwyo gynt. Mae gan y cytundeb hwn werth o £66,300 am y 6 mis cyntaf ac opsiwn i ymestyn am 3 mis arall. Gall gorchmynton sefydlog o ran y gofyn i dendro cytundeb gael eu hepgor er mwyn caniatáu cytundeb tymor byr er mwyn osgoi amhariad mewn cyflawni gwasanaeth plismona.	Executive Summary: North Wales Police have requested a waiver in the standing orders in relation to the procurement of a management provision of the FCIN Project. The service required is an extension of the current contract until the provision can be provided in-house. The current providers are providing a high-quality service. This is the second request for a Waiver, see Waiver reference 2022.20 approved previously. This contract has a value of £66,300 for the first 6 months with an option to extend for a further 3 months. Standing orders in relation to the requirement to tender a contract may be waived to allow a short-term contract to avoid a disruption in delivering a policing service.
