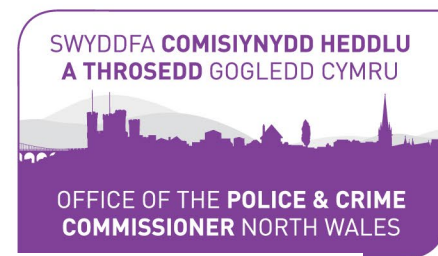

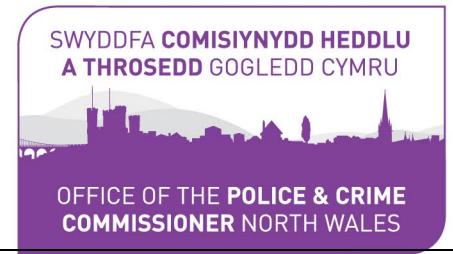

<b>Crynodeb Gweithredol:</b> Mewn cyfarfod bwrdd diweddar o Gymdeithas Comisiynwyr Heddlu a Throsedd (APCC) penderfynwyd penodi Rheolwr Polisi Cymru APCC. Gan fod y swydd hon yn bennaf o fantais i CHTh a heddluoedd Cymru, bydd 50% o'r gost yn cael ei dalu gan yr APCC ac mae'r 50% yn weddill i'w gael ei rannu yn gyfartal rhwng y pedwar CHTh yng Nghymru.	<b>Executive Summary:</b> At a recent board meeting of the Association of Police and Crime Commissioners (APCC) it was decided to appoint a permanent APCC Wales Policy Manager. As this post is primarily to benefit Welsh PCCs and forces, 50% of the cost will be paid by the APCC, and the remaining 50% is to be shared equally among the four Welsh PCCs.
<b>Goblygiadau:</b> Ariannol - tua £7,000 y flwyddyn, yn cynnwys costau Cynllun Heddlu a Throsedd - Mae'r CHTh yng Nghymru yn gweithio gyda'i gilydd a gyda'r APCC i gyflenwi eu cynlluniau.
