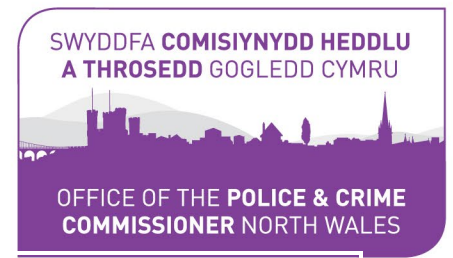

The Police and Crime Commissioner has agreed to contribute towards the cost of the Plan delivery, and towards the Independent Panel on an ongoing basis.
