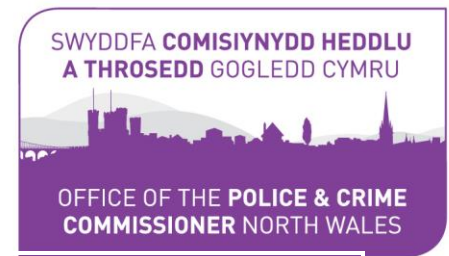

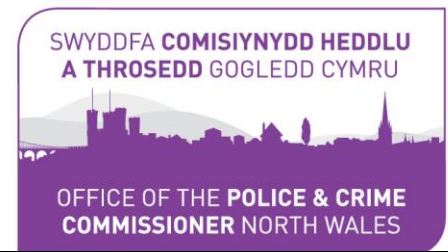

<p>Lansiodd Comisiynydd yr Heddlu a Throsedd y Gronfa Pêl-droed Haf ym mis Gorffennaf wrth ddefnyddio cyllid drwy'r Cynllun Arloesi i Dyfu.</p> <p>Cafodd y Gronfa Pêl-droed yr Haf eu creu i gefnogi problemau fel ymddygiad gwrthgymdeithasol (ASB), a all cynyddu yn aml dros fisoedd yr haf. Nod yr arian oedd cefnogi gweithgareddau pêl-droed a chwaraeon i gadw plant a phobl ifanc yn brysur mewn ffordd gadarnhaol, tra hefyd yn hyrwyddo gwaith tîm, ymarfer corff drwy gydol gwyliau'r haf.</p> <p>Mae dyraniad cyllid ynghlwm hysbysiad penderfynu hwn.</p>	<p>The Police and Crime Commissioner launched the Summer Soccer Fund in July whilst utilising funding via the Innovate to Grow Scheme.</p> <p>The Summer Soccer Fund was created to combat issues such as anti-social behaviour (ASB), which can often spike over the summer months. The aim of the funding was to support football and sporting activities to keep children and young people occupied in a positive way, while also promoting teamwork, exercise throughout the summer holidays.</p> <p>Allocation of funding is attached to this decision notice.</p>

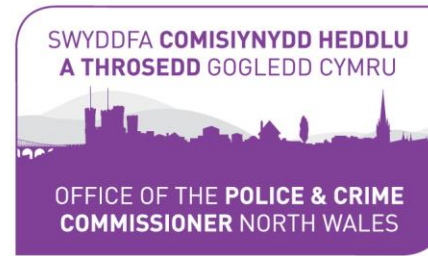

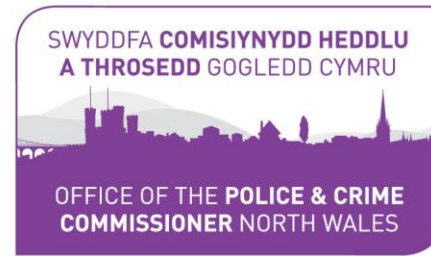
