

Crynodeb Gweithredol: Mae Heddlu Gogledd Cymru wedi gofyn am hepgoriad yn y gorchmynion sefydlog o ran caffaol meddalwedd sy'n gallu categoriiddio a chael gwared ar ddelweddau anweddus. Mae'r feddalwedd eisoes mewn lle, hefo'r cytundeb ar fin dod i ben. Mae cost newid technolegau, datrysiaid newydd a hyfforddiant yn mynd ymhell tu hwnt parhau hefo'r un cyflenwr. Mae'r feddalwedd yn gysylltiedig hefo achrediad yr Uned Fforenseg Digidol. Mae'r cytundeb hwn werth £115,010 dros 5 mlynedd. Gellir hepgor gorchmynion sefydlog o ran yr angen i gynnig am gytundeb os nad ydy newid cyflenwyr yn ddarbodus yn ariannol.	Executive Summary: North Wales Police have requested a waiver in the standing orders in relation to the procurement of a software capable of categorising and removing indecent images. The software is already in place, with the contract due to expire. The cost to change technologies , new solution, training far exceeds remaining with the same supplier. The software is linked to the Digital Forensic Unit's accreditation. This contract has a value of £115,010 over 5 years. Standing orders in relation to the requirement to tender contract may be waived if changing suppliers is not financially prudent.
