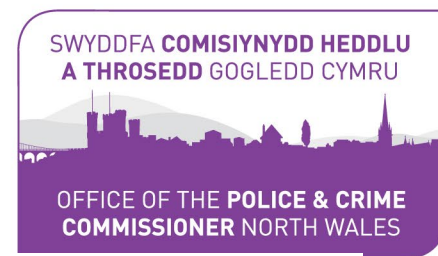

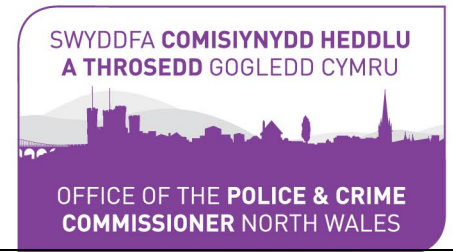

Mae'r feddalwedd eisoes mewn lle, hefo'r cytundeb fod i ddod i ben. Mae cost newid technolegau yn mynd ymhell tu hwnt aros hefo'r un cyflenwr.</p> <p>Mae'r feddalwedd yn gysylltiedig hefo achrediad yr Uned Fforenseg Digidol.</p> <p>Mae'r cytundeb hwn werth £42,980 dros 5 mlynedd.</p> <p>Gellir hepgor gorchmynion sefydlog o ran yr angen i gynnig am gytundeb os nad ydy newid cyflenwyr yn ddarbodus yn ariannol.</p>	<p>North Wales Police have requested a waiver in the standing orders in relation to the procurement of a software capable of a deep dive into digital forensics. The software is already in place, with the contract due to expire. The cost to change technologies far exceeds remaining with the same supplier.</p> <p>The software is linked to the Digital Forensic Unit's accreditation.</p> <p>This contract has a value of £42,980 over 5 years.</p> <p>Standing orders in relation to the requirement to tender contract may be waived if changing suppliers is not financially prudent.</p>
