Crynodeb Gweithredol: Mae Heddlu Gogledd Cymru wedi gofyn am Hepgoriad i'r Gorchmyntion Sefydlog er mwyn cynnal yr ail, trydydd, pedwerydd a pumed rhan o arolwg diwylliannol gyda'r Heddlu. Mae'r Prif Gwnstabl yn gofyn am yr arolwg yn dilyn ei phenodiad a digwyddiadau dilynol yn berthnasol i ymddygiad yn y gwasanaeth plismona a chyfreithlondeb yr heddlu. Bydd yr arolwg yn darparu'r wybodaeth angenrheidiol er mwyn datblygu cylluniau strategol ar gyfer yr Heddlu. Mae'r ail a trydydd rhan gan werth o £64,000 a'r pedwerydd a pumed gan werth o £33,500. Bydd y prosiect yn cymryd 5 i 6 mis i'w gwblhau. Gellir hepgor gorchmyntion sefydlog o ran y gofyniad i gynnig cytundeb er mwyn caniatáu prosiect symud ymlaen yn gyflym. Nid oes yr un darparwr arall ar y fframwaith wedi'i nodi er mwyn cyflawni'r prosiect.	Executive Summary: North Wales Police have requested a Waiver to the Standing Orders to carry out phase 2, 3, 4 and 5 of their cultural survey with the Force. The survey is required by the Chief Constable following her appointment and subsequent events relating to conduct in the policing service and police legitimacy. The survey will provide the necessary information to develop strategic plans for the Force. The second and third phase has a value of £64,000, the fourth and fifth has a value of £33,500 and the project should take 5 to 6 months to complete. Standing orders in relation to the requirement to tender a contract may be waived to allow a project to progress swiftly. No other provider on the framework has been identified to carry out the project.
