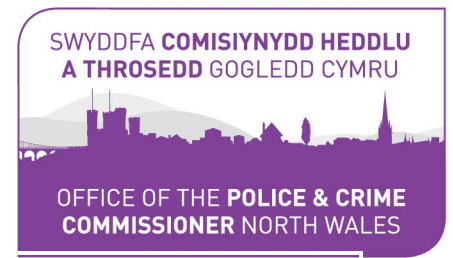

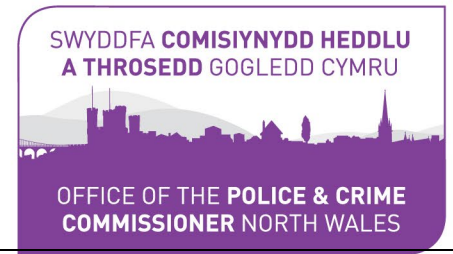

Mae'r trefniadau hyn mewn grym, a gofynnwyd am gyllid pellach am y tair blynedd nesaf, i'w rannu'n gyfartal ymysg y 10 partner.</p> <p>Mae'r CHTh wedi cytuno i'r argymhelliad hwn er mwyn ariannu un rhan o ddeg o gost y swydd.</p>	<p>Continued financial contributions towards business and administration support for the new North Wales Strategic Partnership Boards has been requested for the three-year period October 2023-September 2026.</p> <p>This post has been funded for a 12-month period, as per decision notice number DM2022.33. These arrangements are effective, and further funding has been requested for the next three years, to be shared equally among the 10 partners.</p> <p>The PCC has agreed to this recommendation to fund one tenth of the cost of the post.</p>
