<p>Mae Heddlu Gogledd Cymru wedi gofyn am hepgoriad yn y rheolau sefydlog mewn perthynas â chaffael gwasanaeth gydag arian o'r gronfa Strydoedd Diogelach.</p> <p>Mae'r grant Strydoedd Diogelach ar gael i dargedu problemau thematig, un o'r rhain yw trais yn erbyn merched a genethod mewn llefydd cyhoeddus. Mae dadansoddiad yn dangos bod troseddu yn digwydd mewn sefyllfaoedd addysgiadol.</p> <p>Felly mae angen creu pecynnau addysgiadol i ysgolion er mwyn pwysleisio sut mae diffyg dealltwriaeth neu barch yn cael effaith hir dymor ar ddioddefwyr a sut mae casineb tuag ar ferched sy'n cael eu hyrwyddo gan ddylanwadwyr ar-lein a phornograffi yn dylanwadu ar ymddygiad pobl ifanc.</p> <p>Mae'r prosiect yn cael ei gyflenwi gan RASASCNW i fyfyrwyr hŷn, ond sylweddolwyd erbyn hyn bod angen iddo gael ei gyflwyno i gynulleidfa iau.</p> <p>Mae HGC yn gofyn am £75,000 i gyflenwi'r prosiect hwn am gyfnod o 2 flynedd.</p> <p>Gan fod darparwr y gwasanaeth eisoes yn rhoi'r gwasanaeth hyn i'r gynulleidfa hŷn mae'n bwysig i ddefnyddio'r un darparwr heb angen tendro. Mae'r ddarpariaeth sy'n cael ei gynnig o safon uchel ac yn cael ei ganmol gan ein cydweithwyr ym maes addysg.</p> <p>Gall Gorchmynion Sefydlog yng nghyswllt gofynion cytundeb tendro gael eu hildio os yw'r gofynion yn arbenigol yn eu natur a gall ond cael eu darparu yn rhesymol gan gyflenwr unigol.</p>	<p>North Wales Police have requested a waiver in the standing orders in relation to the procurement of a service with funding from the Safer Streets funds.</p> <p>The Safer Streets grant is available to target specific thematic issues, one of which is one of which is VAWG offending in public spaces. Analysis found that offending is seen in educational settings.</p> <p>There is therefore a need to deliver bespoke educational packages into the school setting in order to highlight how a lack of understanding of or respect for consent leaves life-long impacts on victims and how misogynistic behaviour propagated by online influencers and the ready availability and viewing of pornography influences the behaviours of young people.</p> <p>This project has been delivered by RASASCNW to older students, but it is now found that it needs to be delivered to a younger audience.</p> <p>NWP are requesting £75,000 to deliver this project for a period of 2 years.</p> <p>As the service provider is already providing this service to the older audience it is prudent to use the same provider without the need for a tender. The service provided is of high quality and praised by our colleagues in education.</p> <p>Standing orders in relation to the requirement to tender contract may be waived if the requirement is specialist in nature and can only be reasonably provided by a single supplier.</p>
