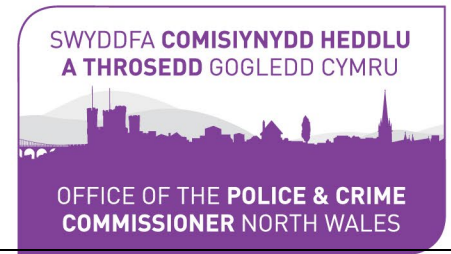

<p>Mae Heddlu Gogledd Cymru wedi gofyn am hepgoriad yn y rheolau sefydlog mewn perthynas â chaffael gwasanaeth gydag arian o'r gronfa Strydoedd Diogelwch.</p> <p>Mae'r grant Strydoedd Diogelach ar gael i dargedu problemau thematig, un o'r rhain yw Ymddygiad Gwrthgymdeithasol.</p> <p>Mae HGC yn gofyn am arian i weithiwr ieuencid arbenigol i weithio ac wedi ei hyfforddi gan sefydliad LFC i mewn i 4 ysgol uwchradd a/neu Unedau Cyfeirio Disgyblion i gynnig cefnogaeth ddwys wedi ei gynllunio yn benodol i unigolion sydd mewn peryg o gamymddwyn cymdeithasol neu ymddygiad troseddol.</p> <p>Mae'r gwasanaeth ar gael yn barod yn Heddlu Glannau Mersi ac nid oes gan unrhyw sefydliad arall yn lleol y gwasanaeth ar gael neu'r gwydnwch i ddarparu gwasanaeth.</p> <p>Mae gan y cytundeb hwn werth o £90,000.00 am gyfnod o 2 flynedd.</p>	<p>North Wales Police have requested a waiver in the standing orders in relation to the procurement of a service with funding from the Safer Streets funds.</p> <p>The Safer Streets grant is available to target specific thematic issues, one of which is Anti-Social Behaviour.</p> <p>NWP are requesting funding to embed a specialist youth worker employed and trained by the LFC foundation into 4 secondary schools and / or Pupil Referral Units to provide bespoke and intensive support to high risk cohorts involved in ASB and/or on the periphery of criminal behaviour.</p> <p>The service is already in place with Merseyside Police, and no other organisation locally has the service available or the resilience to provide.</p> <p>This contract has a value of £90,000.00 for a 2 year period.</p>
