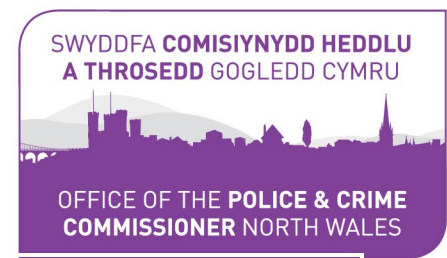

<p>Mae Heddlu Gogledd Cymru wedi gofyn am hepgoriad yn y rheolau sefydlog mewn perthynas â chaffael gwasanaeth gydag arian o'r gronfa Strydoedd Diogelwch.</p> <p>Mae'r grant Strydoedd Diogelach ar gael i dargedu problemau thematig, un o'r rhain yw Ymddygiad Gwrthgymdeithasol.</p> <p>Bydd yr arian hwn yn cefnogi prosiect a fydd yn rhoi cymorth ac addysg i unigolion sydd wedi cael eu nodi gan banel aml-asiantaethol er mwyn annog newid cyfeiriad oddi wrth eu hymddygiad presennol. Mae'r prosiect yn defnyddio gweithgareddau awyr agored i annog y newid hwn.</p> <p>Mae HGC yn gofyn am £47,500 i gefnogi'r prosiect.</p> <p>Gwnaed ymchwil i ddarparwyr eraill sy'n cynnig cyrsiau awyr agored ac nid oes un wedi gallu cynnig yr elfen addysgiadol/ymddygiadol a seicolegol y darparwr.</p> <p>Gall Gorchmynion Sefydlog yng nghyswllt gofynion cytundeb tendro gael ei ildio os yw'r gofynion yn arbenigol yn ei natur a gall ond cael eu darparu yn rhesymol gan gyflenwr unigol.</p>	<p>North Wales Police have requested a waiver in the standing orders in relation to the procurement of a service with funding from the Safer Streets funds.</p> <p>The Safer Streets grant is available to target specific thematic issues, one of which is Anti-Social Behaviour.</p> <p>This funding will support a project which will provide support and education to individuals identified by a multi-agency panel to encourage a change of direction from current behaviour. The project uses outdoor pursuits to encourage this change.</p> <p>NWP are requesting funding of £47,500 to support this project.</p> <p>Research has been undertaken into other providers of outdoor pursuits courses and none have been able to offer the educational/behavioural and psychological element of the provider.</p> <p>Standing orders in relation to the requirement to tender contract may be waived if the requirement is specialist in nature and can only be reasonably provided by a single supplier.</p>
