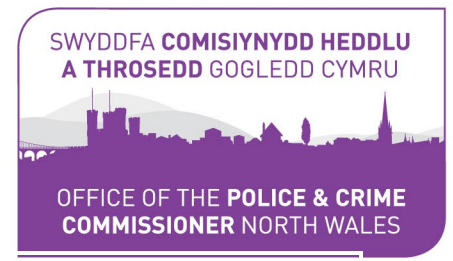

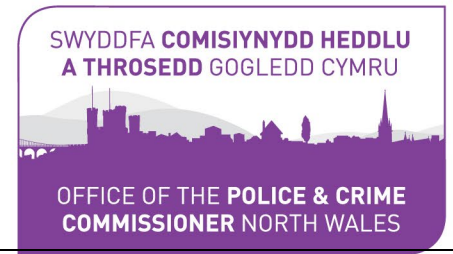

The software is already in place but needs revising.</p> <p>As the software is already in place and just needs revising it is considered prudent to continue with the same service and supplier.</p> <p>Standing orders in relation to the requirement to tender contract may be waived if the requirement is specialist in nature and can only be reasonably provided by a single supplier.</p>
