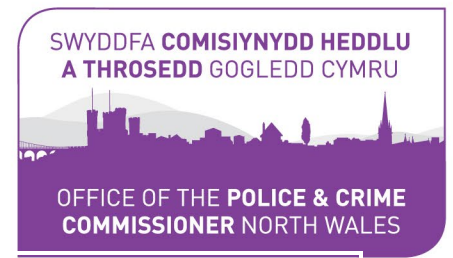


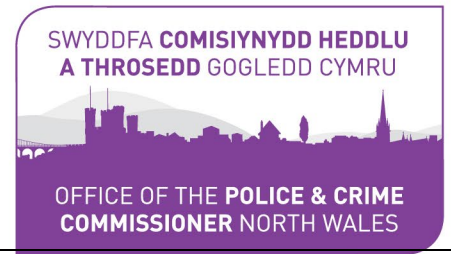

Crynodeb Gweithredol: Sefydlwyd BlueLight Commercial (BLC) er mwyn defnyddio trefniadau prynu casgliadol a hynny er mwyn galluogi plismona gael gwell prisiau ar y nwyddau a'r gwasanaethau sydd eu hangen gan bawb. Cafodd ei ariannu i ddechrau'n ganolog gan y Swyddfa Gartref, ond mae'n bellach ar heddluoedd dalu tanysgrifiad blynyddol.	Executive Summary: BlueLight Commercial (BLC) was established to use collective purchasing arrangements to enable policing to obtain better prices on the goods and services that are required by all. It was initially funded centrally by the Home Office, but it is now a requirement for forces to pay an annual subscription.
Goblygiadau: Ariannol – £10,000 y flwyddyn (cost 2024/25, a all gynyddu yn unol â chwyddiant) i'w ariannu o gyllideb yr heddlu (yn unol â threfniadau tebyg eraill). Y Cynllun Heddlu a Throsedd – mae swyddogaeth gaffael effeithiol ac effeithlon yn sicrhau gwerth am arian drwy sicrhau bod nwyddau a gwasanaethau sy'n cael eu dwyn o ansawdd addas a phris rhesymol. Mae hyn yn ategu'r cynllun heddlu a throsedd drwy sicrhau fod swyddogion a staff hefo offer addas er mwyn cyflawni eu gwaith er mwyn cyflawni'r cynllun. Y Gymraeg – os oes angen ystyried anghenion y Gymraeg, ymdrinnir â hyn yn ystod unrhyw broses gaffael. AD – mae BLC yn cynorthwyo gwaith swyddogaeth gaffael Heddlu Gogledd Cymru. Cydraddoldeb – Dim	Implications: Financial – £10,000 pa (2024/25 cost, this may increase in line with inflation) to be funded from the force's budget (in line with other similar arrangements). Police and Crime Plan – an effective and efficient procurement function ensures value for money by ensuring the goods and services purchased are of suitable quality and reasonable price. This supports the police and crime plan by ensuring officers and staff are suitably equipped to carry out their work to deliver the plan. Welsh language – where Welsh language needs to be considered, this is addressed during any procurement process. HR – BLC supports the work of North Wales Police's procurement function.
