

<p>Mae'r gwaith hwn wedi'i gomisiynu mewn ymateb uniongyrchol i'r gofynion a amlinellir gan y Swyddfa Gartref wrth roi grant bach i awdurdodau a gwasanaethau penodol ledled gogledd Cymru.</p> <p>Bydd y gwaith hwn yn ysbrydoli cyfeiriad rhaglenni gwaith y dyfodol ar gyfer Dyletswydd Trais Difrifol 2024-25.</p> <p>Rhaid i'r gyfres o brosiectau hon ddod i ben erbyn 31 Mawrth 2024.</p> <p>Yn ei Hysbysiad Penderfyniad ar 28 Medi 2023, fe wnaeth y Comisiynydd Heddlu a Throsedd amlinellu'r gwariant ar gyfer y gwaith hwn.</p> <p>Ers i'r penderfyniad hwnnw gael ei wneud, hysbyswyd SCHTh gan CEF Berwyn ar 16 Ionawr 2024 eu bod yn methu dechrau eu prosiect oherwydd newid gofynion gan y darparwr hyfforddiant. Fe wnaethant dynnu eu cais ffurfiol am gyllid o £13,000 yn ôl. Oherwydd amserlen dynn, rhannwyd mynegiant o ddiddordeb i'r 6 Prosiect Dyfodol Heb Drais a oedd yn weddill.</p> <p>Gofynnir y CHTh gymeradwyo cyllid o £13,000 a ail-ddyrannwyd i Ynys Môn er mwyn ehangu eu prosiect Dyfodol Heb Drais cyn 31/3/24.</p>	<p>This work has been commissioned in direct response to the requirements outlined by the Home Office in administering a small grant to specified authorities and services across north Wales.</p> <p>This work will inform the future direction of work programmes for the Serious Violence Duty in 2024-25.</p> <p>This suite of projects must conclude by 31 March 2024.</p> <p>The Police and Crime Commissioner is his Decision Notice dated 28 September 2023 set out the expenditure for this work.</p> <p>Since that decision was made the OPCC were notified by HMP Berwyn on 16 January 2024 that they are unable to commence with their Project due to change of requirements by the Training provider, they formally withdraw their request for £13,000 funding. Due to tight timescale, expression of interest distributed to the remaining 6 Future Without Violence Projects.</p> <p>The PCC is asked to approve £13,000 funding reallocated to Ynys Mon to expand their Future Without Violence project to be delivered before 31/3/24.</p>

HMP Berwyn formally withdrawn from process 16/1/2024.</i>
PLAN UK	£24.997.50	To run a series of events and activities in North Wales with inspirational speakers, workshops and collaborative discussion for both young men & boys and the professionals that support them, to create a vision for a future Wales without Gender Based Violence.
Flintshire Youth Service	£17.400.00	The project will support the Flintshire Youth Justice Service in developing a partnership with Empire Fighting Chance to train and set up and deliver the Box Champion Programme designed

		to empower young people with the skills and inspiration needed to make positive changes in their lives.
Conwy Youth Service	£7,500.00	A multi-agency project which involves Conwy Youth Service, Conwy Family Centre and Youth Justice to provide support for young people and their families as part of the trauma informed approach.
Isle of Anglesey Social Services	£32,557.00 original funding. <i>Additional £13,000 additional funding awarded due to withdrawal of HMP Berwyn project 16/1/24.</i> Total funding £45,557.00	<p>A multi-agency approach working with a range of partners to take the trauma informed approach to the next level through officer CPD and interventions for young people that are becoming a growing concern within their communities through youth-related ASB, crime and peer tensions.</p> <p><i>The additional money would be used by the project to deliver an additional x 2 Mind Mechanics sessions, one of which will be for a High School and the other for Primary School children. These sessions would be delivered in February and March 2024.</i></p>
