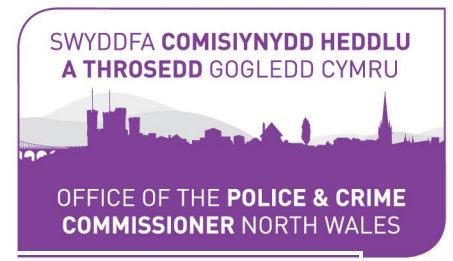

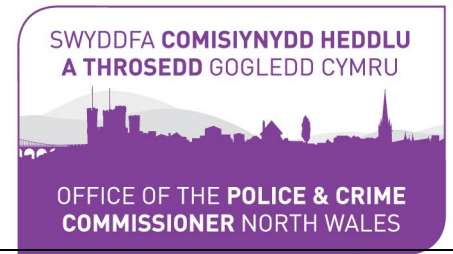

<p>Mae Gorsaf Heddlu Cefn Mawr wedi'i nodi fel lle sydd bellach yn ddiangen ac felly y bwriad yw cael gwared arni. Mae'r Rheoliadau Ariannol yn dweud fod gwarediadau cyfalaf i'w gwneud ar y telerau gorau sydd ar gael. Ar yr un pryd, mae Deddf Lles Cenedlaethau'r Dyfodol (Cymru) 2015 yn gofyn i gyrff cyhoeddus yng Nghymru gofio am werth cymdeithasol wrth ffurfio cytundebau.</p> <p>Penderfynwyd gwerthu'r eiddo i Gyngor Bwrdeistref Sirol Wrecsam am £180,000, sydd tuag at ben uchaf yr ystod fel yr aseswyd gan Asiantaeth y Swyddfa Brisio. Ar ben hyn, ychwanegir cyfamod, er mwyn sicrhau fod y defnydd wedi'i gyfyngu i dai cymdeithasol.</p>	<p>Cefn Mawr Police Station has been identified as surplus to requirements and is therefore to be disposed of. The Financial Regulations state that capital disposals are to be made on the best terms available. At the same time, the Wellbeing of Future Generations (Wales) Act 2015 requires public bodies in Wales to be mindful of social value when forming contracts.</p> <p>It has been decided to sell the property to Wrexham County Borough Council for £180,000, which is towards the higher end of the range as assessed by the Valuation Office Agency. In addition, a covenant is to be added, to ensure the use is restricted to social housing.</p>
